### WHAT WILL HAPPEN WHEN YOU ARE SUMMON TO A MUNICIPAL COURT

If you are issued a summon to attend a municipal court, it is important that you show up. The judge has the power to issue a fine or an arrest warrant for failure to appear. If a warrant is issued, you will receive a notice that a warrant has been issued however if for some reason you do not receive a notice and you have an encounter with the law, due to a traffic stop or for some other reason, you will be arrested and might spend the night in jail until the next day when the judge will see you and determine whether the warrant will be lifted.

An attorney in municipal court is able to advocate on behalf of a client to lift an arrest warrant. Call our office if you are in this situation.

When you show up for municipal court whether in person or virtually, your name will be checked against the list of defendants who are scheduled to appear. You will need to wait patiently until you name is called. If you are represented by an attorney, the attorney will speak

on your behalf with the prosecutor and later will speak to the judge. Clients who are represented by an attorney will be given priority. The Supreme court of New Jersey has given the directive that attorneys are to be seen first in municipal court due to the fact that they are always wanted in other courts to represent other clients and the justice system wants to ensure that every client has his attorney present when they are represented. If you are not represented by an attorney, you will have to wait to speak with the prosecutor and after you speak with the prosecutor you will go in front of the judge. This could take anywhere from one to five hours, so most of the times it will be worthy to hire an attorney who can save you a lot of time. # **HOW TO PAY A MUNICIPAL COURT FINE**

All Municipal courts have a window that you can approach to pay your fines. After your matter has been addressed by the judge, he will direct you to pay at the window. However, many tickets do not require a court appearance and they can be paid at the window without the need to see a judge. Keep in mind that if you decide to pay your fines without a court appearance you will be effectively admitting that you committed the violation of which you are being accused of. If you are paying your fine without seeing a judge, you will need the violation number or ticket number so they can identify which ticket you are paying.

Some fines in municipal court could be paid in installments, however only the judge can approve such plans. So if the money is scarce, it may be a good idea to ask for permission from the judge to pay your fine in installments.

Other courts with multiple court sessions are: Linden Municipal court, Rahway municipal court, Union municipal court, Elizabeth municipal court, Clifton municipal court, Passaic municipal court, Paterson municipal court, Jersey City municipal court, New Brunswick municipal court and many others have multiple court rooms and judges.

After Covid some of these courts converted to a mix of virtual and personal appearances. The virtual appearances are convenient for those that need the flexibility to connect from work or home. However, one of the drawbacks to a virtual appearance is the fact that most people do not know how a virtual court is conducted and the long wait may cause confusion and anxiety. It is worth saying that municipal court are mostly a convenience for those who might not otherwise be able to appear personally.

If you are summoned for a virtual municipal court, you will likely need to appear through zoom, a video application which allow you to connect using your phone, computer or tablet.
